

Question: Does Hanover assign book and page numbers to land records and judgments?

Answer: Yes. Where book and page numbers are assigned, that is the preferred manner of referring to documents.

Question: What monitor resolution is best for viewing the online system?

Answer: 1280 x 960 or higher.

Question: Are search results returned by the SRA system in a different fashion than by the land records management system in the Hanover Circuit Court Clerk's Office?

Answer: Yes. To ensure the fastest response time to search requests (including name searches), the SRA system does not sort results by date or alphabetically. See pages 2 and 3 of this document to learn how to sort search results alphabetically and by date.

To sort records by name in date order do the following.
